

The plaintiffs interest was primarily in the debt, not in the land. The vendor has in my opinion no right to convey the legal estate in the land to him. The vendors lien is in such a case nothing other than the right to keep the title in his own name until he is paid and, perhaps, to exercise with or without the sanction of the Court a right of re-sale. But granting, as no doubt in some form or other is the case, that the plaintiff had an interest in the land which would support a caveat I think his caveat protected him...
